Facility:	Georgetown YMCA, 529 Browns Ferry Road, Georgetown, SC 29440. Indoor 6-lane 25-yard pool with 6" Competitor non-turbulent lane lines, bottom striped and wall targets. The water depth of the competition course is 5 feet measured from one (1) meter to five (5) meters at the starting end of the course and 4 feet measured from one(1) meter to five(5) meters at the turn end of the course. Colorado Timing Systems electronic timing and display board will be used. Parking will be available at the YMCA parking lot. The competition course has not been certified in accordance with 104.2..2C(4). Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, officials and/or spectators are present).
Rules:	Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Deck changes are prohibited.

<p>Athlete Eligibility:</p>	<p>This competition is open to all members of USA-Swimming in good standing with the following teams within the circuit: CAC, FINS, FAST, GCYW, H2A, ION, MBR, NC, SMRT, SWIM.</p> <p>Age is determined by the first day of the meet. No swimmer may swim in events for which s/he has a 2017-2018 State Qualifying time. No swimmer may swim in an Open event for which s/he has the 13/14 2017-2018 State Qualifying time, regardless of age. No swimmer may swim in an Open event for which s/he has an Age Group Sectional Qualifying time in their age group, regardless of age.</p> <p>Any swimmer entered in the meet, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</p>
<p>Entry Fees:</p>	<p>Entry Fee \$24.00 per swimmer (\$20.00 Pool fee + \$2.00 SCLSC Travel Fund / Program Fee + \$2.00 SCLSC Sports Development Fee). Make checks payable to Coastal Aquatic Club. Entry fees are non-refundable. The Clerk of Course will accept deck entries for open lanes only. Payment for all deck entries is due before the end of warm-ups to Clerk of Course. The deck entry fee is \$7.00 per event. Athletes may enter 4 individual events including time trials.</p> <p>Time trials cost per event \$ 7.00</p>
<p>Meet Format:</p>	<p>All events will be contested as Timed Finals.</p> <p>Warm-up procedures: Team lane assignments will be made for each session. All SCLSC and USA Swimming safety guidelines will be enforced. Breaks will be added to provide adequate warm-down to the swimmers.</p> <p>Meet Management reserves the right to limit the number of heats based on the number of entries.</p>
