Facilities: Pepper Geddings Recreation Center, 3205 North Oak St. Myrtle Beach, SC 29577. Indoor 6-lane 25-yard pool with 6" Competitor non-turbulent lane lines, bottom striped and wall targets, 4-lane warm-up pool. The water depth of the competition course is 12 feet measured from one (1) meter to five (5) meters at the starting end of the course and 4 feet measured from one(1) meter to five(5) meters at the turn end of the course. Colorado Timing Systems electronic timing and display board will be used. Mezzanine spectator seating for 350 will be available. Parking will be available in the Pepper Geddings parking lot. The competition course has not been certified in accordance with 104.2..2C(4).

Rules: Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Athlete

Eligibility: All swimmers and teams must be currently registered members of USA-Swimming. Age is to be determined by the first day of the meet. Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Entry Fees: \$3.00 per individual event. \$6.00 per individual Time Trial. \$14.00 per swimmer pool charge. \$6.00 per relay team entry. \$2.00 SCLSC Travel Fund/Program Fee, \$2.00 SCLSC Sports Development Fee. \$2.00 Out-of-state SCLSC Travel Fund/Program Fee. \$6.00 per event for deck entered. Entry fees are non-refundable. Swimmers may swim up to four (4) individual events per day, including Time Trials. Teams may enter up to four (4) relays per age-group per event. The Clerk of Course will close 30 minutes before the start of competition of each session. Late entries fee will be double the original entry fee per event. Late entries must show their USAS registration card to the Clerk of Course to verify current USAS membership. Late entries may also use deck-pass or a roster as proof of registration.

Meet Format: All events will be contested as Timed Finals.

- All events 400 yards and longer are Positive Check-in and will be swum Fastest to Slowest. Positive check-in will close 30 minutes after the start of warm-ups.
- Swimmers competing in event 500 yards must provide their own counters.
- Time Trials will be conducted at the conclusion of the session at the discretion of the Meet Referee.
- Late entries will only be accepted for empty lanes. No additional heats will be created.

Teams will be assigned lanes and sessions for all warm-ups. Meet director reserves right to adjust times.

Entries: Entries will not be considered official until hardcopy, financial summary sheet and check are received. SC Swimming does not accept deck registrations. All swimmers entered must be registered at time of entry deadline. Please mail entries to P.O.BOX 1245 Myrtle Beach, SC 29578. All entries must be received by Tuesday, October 13, 2015. Event file will also be available on the SC Swimming website.
