Facilities: North Myrtle Beach Aquatic and Fitness Center. 1100 2nd Avenue South, North Myrtle Beach, SC 29582. Indoor 8-lane 25-yard pool with 6" competitor non-turbulent lanes, bottom striped and wall targets, 3-lane warm-up pool. Colorado Timing Systems electronic timing and display board will be used. The water depth is 8 feet, measured from 1 to 5 meters on the starting end of the course and 4.5 feet, measured from 1 to 5 meters at the turn end of the course. The competition course has not been certified in accordance with 104.2.2c(5). On deck seating is available to coaches and swimmers. Additional seating is outside on an adjacent patio. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/ coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and /or spectators are present.

Rules: Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Deck changes are prohibited. SWIMWEAR: Swimmers 10 years old and younger are not permitted to wear "Technical" suits at this meet.

Athlete

Eligibility: All swimmers and teams must be currently registered members of South Carolina Swimming and USA-Swimming. Swimmers may enter any event in which they do not have a Age Group Sectional or Senior Sectional (Spring) qualification cut. Age is to be determined by the first day of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming member-coach, it is the responsibility of the swimmer's legal guardian to ensure compliance with this requirement.

Entry Fees: \$4.00 per individual event. \$8.00 per individual Time Trial. \$21.00 per swimmer pool charge. \$8.00 per relay team entry. \$2.00 SCLSC Travel Fund/Program Fee, \$2.00 SCLSC Sports Development Fee. \$2.00 Out-of-state SCLSC Travel Fund/Program Fee. \$7.00 per event for deck entered. Entry fees are non-refundable. Swimmers may swim up to three (4) individual events per day, including Time Trials. Teams may enter up to six (6) relays per age-group per event. The Clerk of Course will close 30 minutes before the start of competition of each session. Late entries fee will be double the original entry fee per event. Late entries must show their USAS registration card to the Clerk of Course to verify current USAS membership. Late entries may also use deck-pass or a roster generated by the South Carolina Swimming as proof of registration.

Meet Format: All events will be contested as Timed Finals.

- All events 400 yards and longer are Positive Check-in and will be swum Fastest to Slowest. Positive check-in will close 30 minutes after the start of warm-ups.
- Swimmers competing in event 500 yards must provide their own counters.
- Time Trials will be conducted at the conclusion of the session at the discretion of the Meet Referee.
- Late entries will only be accepted for empty lanes. No additional heats will be created.
