Wahoo Aquatic Club COVID-19 Meet Plan

- The listed Safety Marshal is responsible for coordinating Return to Competition Plan and SafeSport Protocols.
- All non-competing persons ie officials, coaches, timers, and meet administrators must wear masks at all times. Face shields are not a substitute for a face mask. Shields may be worn in addition to masks, but not in place of a mask.
- Entrance to the pool will be through the main pool entrance. No swimmers or are to sit in the breezeway area. This area is to be kept clear as the entrance and exit to the facility. All swimmers must come onto the pool deck and sit in assigned team area.
- No Spectators on deck or on the grass outside of the facility. Parents may sit in their cars in the parking lot, if they wish to stay on site during the meet.
- We will not Live Stream this event.
- Parents may have access to their swimmers in the following ways:
 - 1- Meet Mobile
 - 2- Emergency contact station. 1 meet volunteer personnel will be stationed outside of the main gate. If any parent has an emergency, he/she will let the meet volunteer at the gate know; he/she will go on the deck, retrieve the swimmer, and bring to his/her parents.
 - 3- The concessions volunteer will carry a cell phone that is charged. Any swimmer, in case of emergency, may call his/her parent from this phone. Swimmers should know their emergency contact numbers.
- Swimmers must arrive in their suits. Locker rooms will be designated for restroom use only. No changing or showering will be allowed. Locker room and restroom use must comply with all Safesport guidelines.
- Meet Personnel for each session are as follows: 14 Timers; , 2 Officials, 1 Safety
 Marshal, 1 Meet Referee, 1 Deck Referee, 1 Administrative Official, 1 Computer/Console
 operator, 1 Meet Director, 1 Starter. 1 coach per 15 athletes will be allowed on deck.
- There will be no more than 28 Meet Personnel on deck for each session. According to state and local guidelines, the pool capacity is 250. We will adhere to current social distancing guidelines.
- Pre-meet warm-ups will adhere to social distancing guidelines
- For the 10 and under session: There will be no warmup or warm down lane available during the meet.
- For the 11 and over session: There will be no warmup or warm down lane available during the meet. To allow for warm downs, swimmers will complete their race. Then, after all swimmers in the heat are done, they will swim a 25 warm-down, exiting the pool at the shallow end. This will give swimmers a brief warm down plus will ensure that all swimmers exit at the end of the pool opposite the timers and upcoming heats. The Meet Director will create 10 minute warm-down sessions based on swimmer counts and safe social distancing.
- Seating for swimmers will be assigned by team. Swimmers should socially distance with teammates. All swimmers should bring their own seating.
- There will be a minimum of 30 minutes in between sessions to allow for full facility evacuation and disinfection.
- Hospitality for coaches and officials will be prepacked snacks and drinks. The hospitality room will not be open. Water will be available poolside. Coaches and officials will have access to the indoor Team Meeting room to cool down.
- Wahoo Aquatic Club volunteers will be on hand to ensure all safety precautions and facility guidelines are followed.
- If possible, Coaches and Officials meetings will be held virtually prior to the start of the meet.
- There will be no vendors at the meet. Concessions may be provided in the area outside the pool.

 Failure to comply with the submitted COVID-19 Meet Plan could result in the sanction being rescinded and possible denial of future sanctions for a term of not longer than one season (short course or long course).

Facility:

LTP Swimming Pool 1513 Mathis Ferry Road Mt. Pleasant, SC 29464

A partially covered, 8 lane 25 yard pool. No separate warm up/warm down area is available. The water depth of the competition course is 6 to 5 ½ feet measured from one (1) meter to five (5) meters at the starting end of the course and 4 to 4 ½ feet measured from one (1) meter to five (5) meters at the turn end of the course. The pool is equipped with lane lines and starting blocks. The competition course has not been certified in accordance with 104.2.2C(4).

NO SPECTATORS ON DECK OR ON THE GRASS SURROUNDING THE FACILITY. This meet will be a drop off competition. Swimmers, while awaiting for pick up outside of the breezeway, must wear masks. Only meet volunteers, USA Swimming registered athletes, and current USA Swimming registered officials and coaches are allowed behind the starting blocks.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Facility Rules:

- *NO glass containers allowed in the pool area or in locker rooms.
- *Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms
- *Folding chairs are allowed on deck in designated areas. .
- *Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Rules:

Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. The Meet Referee reserves the right to adjust the warm-up times and start times. Use of audio or visual recording devices, including a cell phone, is not allowed behind the starting blocks. Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet. SWIMWEAR: No Technical Suit maybe worn by any 12 & under USA Swimming athlete member in competition at any Sanctioned, Approved, or Observed meet (effective September 1, 2020).

All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Athlete Eligibility: This competition is open to any USA Swimming registered athletes. All swimmers and teams must be currently registered members of USA Swimming, Inc. Age is to be determined by the first day of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Entry Fees:

Athletes may enter up to 6 events. Athletes may only swim in ONE session.

Meet Format:

- Meet management reserves the right to change the format of the meet, move an age
 group to another session, or make any other necessary changes during the meet to
 provide the best competition environment for the athletes, including adjusting the
 number of sessions, heats, lanes and warm-up times. Events may be combined but
 awarded separately by gender and age group as needed. Meet management reserves the
 right to make any changes to format, timeline, or sessions to comply with best practices
 for social distancing and health concerns.
- All events will be contested as Timed Finals.
- Time Trials will be held at the conclusion of each session. Swimmers must submit time trial money and events by Event #10 (First session) and Event #30 (Second session). Swimmers may only swim in one session; this includes time trials. Each time trial counts as an event. Swimmers may not exceed 5 events. The Meet Director will limit Time Trials events- no 1650 Freestyle; no 1000 Freestyle.
- The meet is limited to the first 250 swimmers entered in the meet, provided no session has more swimmers than can be accommodated with social distancing requirements. That number is currently 120 swimmers per session.
- Timers will be provided by the host team and other volunteers for all events.
- General warm-up procedures apply. All SCLSC and USA Swimming safety guidelines will be
 enforced. Specific warm-up procedures will be posted on deck and provided in the coaches'
 packets. Coaches are advised to closely supervise their swimmers at all times. Diving is
 permitted only during specific warm-up times, as announced. Running and horseplay are
 prohibited. The use of pull buoys, paddles, kickboards, bands, tubing and other equipment
 is prohibited.
- Entries received by the deadline date will be considered team entries and no refunds for no shows will be issued.
- All 25-yard events will be started at the deep end of the pool. Timers will walk to the shallow end for all 25-yard events.
