Masks are still encouraged as a preventative measure as given by the CDC guideline</p> <p>All COVID-19 protocols required by facilities and local governments will be followed.</p> <p>Masks are still encouraged as a preventive measure as given by CDC guidelines.</p> <p>The capacity of the facility is 1000.</p> <p>Parents/Guardians will be able to observe and have access to their minor children in the following manner: outside area, gym, live streaming, etc...</p> <p>Failure to comply with the COVID-19 protocols of a particular facility could result in the sanction being rescinded and possible denial of future sanctions for a term of not longer than one season (short course or long course).</p>



<p>Facility:</p>	<p>Indoor 10-lane 50-meter competition pool with a moveable bulkhead and 8-lane 25-yard warm-down pool with non-turbulent lane lines. Bleacher seating for over 1000 is available. Spectators may bring chairs and tents to use on the outside patios and grass areas. Chairs, food and coolers are not permitted on the pool deck.</p> <p>The water depth of the competition course is seven (7) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and seven (7) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The water depth of the warm down course is six (6) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and four (4) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The competition course has not been certified in accordance with 104.2.2C</p> <p>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</p>
<p>Rules:</p>	<ol style="list-style-type: none"> 1. Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. 2. In accordance with USA Swimming there will be a designated swimmer area. This area will be clearly marked and is only open to those swimming in the meet. Parents are asked to sit in the designated spectator area. 3. All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP 2.0 policy is a condition of participation in the conduct of this competition. 4. SWIMWEAR: No Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet (USA Swimming Rule 102.81.1.F). No Equipment will be allowed in warm-up. 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Use of these devices is also not allowed behind the starting blocks. 6. Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet.
<p>Athlete Eligibility:</p>	<p>This meet is open to all swimmers currently registered with USA Swimming. All USA Swimming registration numbers will be verified with SWIMS. Age is to be determined on the first day of the meet.</p> <p>USA Swimming registrations will not be accepted on deck. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.</p>



<p>Image Release:</p>	<p>By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team’s head coach and the Meet Director prior to the start of the meet.</p>

Entry fees are non-refundable. Entry Limit: <ul style="list-style-type: none"> ● 13 and over athletes may enter up to 3 individual events per day. And no more than 9 individual events for the meet. Time Trial events are included in entry limits. ● 12 and under athletes may enter up to 4 individual events per day. And no more than 10 individual events for the meet. Time Trial events are included in entry limits. </p>
<p>Meet Format:</p>	<ol style="list-style-type: none"> 1. The total number of eligible swimmers per session is set at 300 swimmers for the 12&U session and at 300 swimmers for the 13&Over Session. The Meet Director reserves the right to adjust warm-up times & start times, limit events, heats, number of swimmers per team, or to adjust the format to conform with the 4-hour provision for 12 and Under sessions in accordance with Rule 205.3.1 F as well as to conform to the local protocols and requirements established due to Covid-19. Teams will be notified of any adjustments as soon as the deadline for entries received has passed. 2. Warm-up procedures: Team lane assignments will be made for each session. All SCLSC and USA Swimming safety guidelines will be enforced. In order for swimmers to warm up a USA Registered coach must be present. If a coach cannot attend warm-up for his or her team please contact the meet host. 3. All events will be contested as combined male and female. 4. All Friday night events will be positively checked in. The 13&O 400 free on Saturday evening will be positively checked in. 5. Seeding: <ol style="list-style-type: none"> a. All events will be seeded as combined male and female. b. All Friday evening events will require a positive check-in, will be seeded on deck, and run fastest to slowest heats. Meet host reserves the right to limit the 1500 free and the 400 IM to conform to the meet timeline. c. Saturday morning’s Open 400 Free will run fastest to slowest heats. Meet host reserves the right to limit the Open 400 Free to conform to the meet timeline. 6. Swimmers may choose to have a counter for the 1500 free. All counters if possible must be a fellow swimmer/teammate. If no counter can be found then a parent may count with Meet Director approval. 7. A swimmer that misses their assigned heat will not be entered into another heat of that event unless circumstances are beyond the swimmer's control as determined by the meet referee and the swimmer may be allowed to swim.



	<p>8. The adjacent 8-lane therapy pool will be open for warm-up/warm-down during the meet at the discretion of the meet ref.</p> <p>9. Meet management reserves the right to insert breaks in the meet where necessary to allow athletes proper rest.</p> <p>10. "Open" events can be swum by any athlete who meets the national age group motivational 11-12 BB time standard.</p>
Scratch Rule:	<p>1. Events Seeded on Deck (All Friday events and the Open 400 Free). Any swimmer entered in an individual event that is seeded on the deck, in whole or in part, will need to be positively checked in in order to compete in the event. Failure to scratch prior to seeding and not swimming the event will result in the swimmer being barred from the next individual event in which the swimmer is entered in the meet.</p> <p>2. There will be no penalty for not swimming pre-seeded events; it would be appreciated if a coach would inform Clerk of Course of any swimmers scratching from the meet.</p>
Time Trials:	<p>Times trials will be offered at the discretion of the meet director. Time trial events count toward a swimmer's total number of events. Athletes must furnish their own timer.</p> <p>All time trial entries must be paid in cash at the clerk-of-course prior to the swim.</p>
Time of Meet:	<ul style="list-style-type: none"> ● Fri WU: 3:00 PM and Meet will begin at 4:30 PM ● Sat/Sun 13&O WU: 7:30 AM and meet will begin at 8:45 AM ● Sat/Sun 12&U WU: meet will begin 60min after the conclusion of the AM session But will not start earlier than 12:30p.
Entry Details:	<p>Entries will be accepted once the meet is sanctioned. Teams not accepted will have their entries returned as soon as possible. Any accepted team entries may be updated until Tuesday, May 10 at 5:00 PM.</p> <p>Entries are to be sent to Sports Timing, Inc. Go to www.sportstiming.com, click on upcoming meets, and click on the 2022 Moc's May Flowers Meet. Complete the form, upload your entry file and click submit. You will receive an email confirmation. If you need to submit updated entry files, you are able to submit a new form and file.
