Indoor 8-lane 25-yard pool with 6" Competitor non-turbulent lane lines, bottom striped and wall targets, 4-lane warm-up pool. Colorado Timing Systems electronic timing and display board will be used. The water depth is 8 feet, measured from 1 to 5 meters on the starting end of the course and 4.5 feet, measured from 1 to 5 meters at the turn end of the course. The competition course has not been certified in accordance with 104.2.2c(4). On deck seating is available to coaches and swimmers. Additional seating is outside on an adjacent patio. Teams should bring tent-structures for athletes, parents. All areas other than spectator seating and pool facility are off-limits.

Medical supervision will be provided by facility lifeguards.

AED on site.

Rules: The meet will be conducted in accordance with the current USA Swimming and

SC Swimming Rules and Regulations and information herein.

Use audio or visual recording devices, including a cell phone, are not permitted

in changing areas, restrooms, or locker rooms. \

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any

time athletes, coaches, officials and/or spectators are present.

Deck changing is prohibited by both USA and SC Swimming. A first offense will result in the disqualification of the offending swimmer from the next

scheduled event.

The second offense for the same swimmer will result in disqualification from the remainder of the meet.

SWIMWEAR: No technical suit may be worn by any 12&U USA member in Competition at any Sanctioned, Approved or Observed meet. (USA Swimming Rule 102.8.1F.)

MAAPP 2.0: All adults participating in or associated with this meet Acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand the compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Athlete

Eligibility:

This competition is open to all members of USA swimming in good standing. Age is determined by the first day of the meet-November 1, 2024. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Image Release:

By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the start of the meet.

Entry Limit:

225 swimmers or 4-hour timeline, whichever comes first.

Each swimmer may compete in one (1) event on Friday, and up to 4

Individual events for each Saturday and Sunday.

Meet Format: All events will be timed finals.

Events 400 yards and longer are POSITIVE CHECK-IN

Positive check in will close 30 minutes before the start of each session. Late entries at that time will be taken at the discretion of the meet director.

Events may be combined and scored separately as needed.

We will be running one 8 lane course for the meet.

There will be lanes of warm-up warm down during the meet.

Swimmers will be responsible for swimming in their assigned heats and lanes. The Meet Referee has the discretion to determine the need to do dive-over starts.

Swimmers wishing to have a counter for events of 500 yards or more must provide their own.

Time of Meet: Friday warm-up: 4:00pm, Competition will begin at 5:00pm.

Saturday warm-ups: 7:00am, Competition will begin at 8:30 am. Sunday warm-ups: 8am. Competition will begin at 930 am.

Warm up and meet start times may be adjusted once all entries have been

rec'd.

Entries: Electronic Entries - Entries must be in Standard Data Interchange (.SD3)

format and sent as an attachment to the meet entry coordinator. Entry Submission: go to www.sportstiming.com. Free text email entries will not be accepted. List swimmer, sex, age, USA Swimming #. List all attending coaches and contact phone numbers in the body of the email. Corrupted, unreadable, or incorrectly formatted files must be corrected within 24 hours of entry deadline. Errors in entries submitted electronically are the responsibility of the coach. Electronic confirmation will be sent within 48 hours after receipt of file. SC Swimming does not accept deck registrations, all swimmers entered must be registered at the time of entry deadline. The signed release form, Summary sheet and payment in full must be sent to the Meet Director for your entries to be considered complete.

Entries must be electronically postmarked by October 22, 2024.

Late entries will be treated as deck entries and charged double fees.
