Indoor 10-lane 50-meter competition pool with a moveable bulkhead and 8-lane 25-yard warm down pool. Bleacher seating for over 1000. Spectators may bring chairs and tents to use on the outside patios and grass areas.

The water depth of the competition course is seven (7) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and seven (7) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The water depth of the warm down course is six (6) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and four (4) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The competition course has not been certified in accordance with 104.2.2C

NO smoking is allowed inside the facility. NO coolers allowed inside the facility.

NO glass containers allowed inside the facility.

NO folding chairs or seatbacks allowed in the facility. Bleachers seating will be available.

Spectators are limited to designated areas. Reserving seats between sessions is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Lifeguards will be present for medical supervision.

**Rules:** The meet is to be conducted in accordance with the current USA Swimming and SC Swimming

Rules and Regulations and information herein. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Recording devices are also not permitted behind the starting blocks. Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet.

MAAPP 2.0: All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

SWIMWEAR: No Technical Suit may be worn by any 12&Under USA Swimming Athlete member in competition at any Sanctioned, approved or observed meet (USA Swimming Rule 102.8.1F)

No equipment will be allowed in warm up.

#### **Athlete Eligibility:**

All swimmers and clubs must be currently registered members of USA-Swimming Inc. Age is to be determined by the first day of the meet.

Any swimmer entered in the meet must be certified by USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming Member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

### **Image Release:**

By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians or minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their club's head coach and the Meet Director prior to the start of the meet.

### **Entry Fees:**

\$5.00 per individual event \$28.00 pool fee per swimmer \$2.00 SCLSC Travel Fund/Program Fee \$2.00 SCLSC Sports Development Fee \$2.00 Out-of-SCLSC Travel Fund/Program Fee \$5.00 electronic heat sheet Fee \$8.00 per individual Time Trial.

Faxed entries will not be accepted. All entry fees must be paid before the meet begins. Late entries and deck entries will be accepted at the discretion of the Meet Director and at double the regular event fee for empty lane only. No additional heats will be created for deck or late entries.

Swimmers may enter up to **two (2)** individual events on Friday and **four (4)** individual events on Saturday and Sunday. Meet management may allow time trials for swimmers entered in the meet not to exceed a total of **five (5)** entries per day – **swimmers may enter 4 individual events and add 1 time trial for a total of 5 events a day.** The Clerk of Course will close 30 minutes before the start of competition of each session. Late entries fee will be double the original entry fee per event. Proof of registration must be presented.

No refunds will be given unless events are cancelled as stated below.

#### **Meet Format:**

The Meet Director reserves the right to adjust the warm-up times & start times. This is a timed finals meet and will be limited to no more than 325 swimmers per session and/or 650 total athletes entered in the entire meet. The Meet Director reserves the right to limit events, heats, number of swimmers per team, or to adjust the format to conform with the 4 hour provision for 12 and Under sessions in accordance with Rule 205.3.1 F. Teams will be notified of any adjustments as soon as the deadline for entries received has passed. If Events are canceled, refund will be given.

Team lane assignments will be made for each session. All SCLSC and USA Swimming safety guidelines will be enforced.

The meet will be conducted according to this meet information and the SCLSC Policies and Procedures.

All events 400 meter and longer will be deck seeded, require positive check in, and will be swum fast to slow alternating heats of women and men.

Each swimmer in distance events (800 Free, 400 Free and 400 IM) will be required to provide their own timer and counter when appropriate.

Swimmers that check-in and do not appear for an event 400 meters or longer will be disqualified from their next scheduled event. All other events will be pre-seeded. Pre-seeded events will have no penalty for scratching.

Time Trials will be conducted at the end of each session and at the discretion of the Meet Referee.

Time Trials fees must be paid upon entry at the Clerk of Course.

Each swimmer in a time trial will be required to provide their own timer.
