The aquatics facility at the Oakbrook Family YMCA is an outdoor facility consisting of a six (6) lane 25 meter competition pool. The water depth of the competition course is six (5) feet measured from one (1) meter to five (5) meters at the starting end of the course and three and a half (3.5) feet measured from one (1) meter to five (5) meters at the turn end of the course. The competition pool has bottom striping, wall targets, and competition starting blocks. The facility has girls’ and boys’ restrooms for all swimmers. Additional restrooms are available for spectators/volunteers/coaches outside the pool deck. The competition course has not been certified in accordance with 104.2.2C

Medical supervision will be provided by lifeguard staff. There is an AED onsite.

Rules: Meet to be conducted in accordance with the current YMCA of National Competitive Swimming and Diving Rules and Regulations and information herein. This is a closed meet and only open to any CYSL League Team. CYSL League By-Laws will also govern this meet.
Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet.

SWIMWEAR: No Technical Suit may be worn by any 12 & under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet (USA Swimming Rule 102.8.1F)
MAAPP 2.0: All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Athlete Eligibility: This meet is open to all swimmers and teams currently members of any CYSL team in South Carolina. Age is determined on the first day of the meet, July 25, 2025.

A swimmer must have swum in one CYSL League meet during the summer season to qualify for

Championships. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Image Release: By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the start of the meet.

Entry Fees: Swimmers may swim 9 total=5 individual+4 relays.

No refunds once entries have been accepted.

No Time Trials offered.

Clubs should submit a Single Check payable to Summerville Family YMCA for the full amount due. All fees must be paid prior to any swimmer entering the pool.

Meet Format: All events will be contested as timed finals.

- Meet management reserves the right to adjust numbers of heats, lanes, entry limits, and Warm up times based on the number of entries. We will only swim the events listed in the meet information.

This is a Closed YMCA Meet, held under the approval of USA Swimming.

Age as of July 25, 2025 will be used as the competition age per CYSL Swimming Rules.

- Age groups for this meet will be 6 & Under, 7-8, 9-10, 11-12, 13-14, 15-18 and 19-21.
- Genders and age groups may be seeded together for individual events
- Genders will be seeded and grouped together for relays
- A swimmer who misses their assigned heat will not be entered into another heat unless determined by the Meet Referee and the swimmer may be allowed to swim.
- No refunds will be given.

Time of Meet: Meet management reserves the right to adjust warm up times and start times based on number of entries

Entries: Entry Limits:
9 total=5 individual+4 relays
Friday session: 2 relays, 2 individual events
Saturday sessions: 2 relays, 3 individual events.

Only entries using Standard Data Interchange format (SDIF/SD3) will be accepted. Entry files should be submitted by email on or before the due date. You must also provide an entries list in pdf format and a current roster also in pdf format via mail or email.

Event file can be found on the CYSL web site and also located on Summerville YMCA Tidalwaves website. CYSL does not accept deck registrations, all swimmers entered must be registered at time of entry deadline.

The entry deadline for electronic (SDIF/SD3) entries must be submitted to Susan Nesselrode (susanN@summervillemca.org) and **must be received no later than 12:00 pm, July 16, 2025.**

All required paperwork must be submitted before the meet starts. Questions up to the deadline can be addressed to susanN@summervillemca.org or tiffany.wessler@sim.org. Teams are responsible for the delivery of entries on time.

Awards: Medals will be awarded for 1st, 2nd and 3rd place for individual events and relays. Ribbons will be awarded for 4th through 8th place. Heat awards will be given for all events/heats. High Point awards will be awarded in each age group/gender for 1st, 2nd & 3rd place. Team trophies will be awarded to the top three teams. A banner will be awarded to the 1st place team.
Teams are responsible for picking up ribbons after the meet. Ribbons will NOT be mailed.

Scoring: The championship meet will be scored to 10 places. Individual: 11, 9, 8, 7, 6, 5, 4, 3, 2, 1
Relays: 22, 18, 16, 14, 12, 10, 8, 6, 4, 2
Only 1 relay per team may score per event.
All-Star Relays are not scored

Timing: Dolphin timing system & stop watches

Coaches Eligibility: Coaches must be a current member in good standing with the YMCA of the USA.
All coaches will be required to check-in prior to the warm-ups and present their credentials in order to receive their coach's packet.

No individuals without credentials shall be allowed behind the blocks or on the deck during meet warm-ups or competition.

A coaches meeting will be held 15 minutes prior to the beginning of each session. Each team should have one representative or coach present for this meeting. Meet management reserves the right to hold this meeting virtually, 24-48 hours prior to the meet start.
