Indoor 20-lane 25-yard competition pool with a moveable bulkhead and 8-lane 25 yard warm down pool. Bleacher seating for over 1000. Spectators may bring chairs and tents to use on the outside patios and grass areas. Chairs, food and coolers are not permitted on the pool deck.

The water depth of the competition course is seven (7) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and seven (7) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The water depth of the warm down course is six (6) feet, measured from one (1) meter to five (5) meters, on the starting end of the course, and four (4) feet, measured from one (1) meter to five (5) meters, at the turn end of the course. The competition course has not been certified in accordance with 104.2.2C

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Lifeguards will be present for medical supervision.

Rules:

Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

SWIMWEAR: No Technical Suit may be worn by any 12&Under USA Swimming member in competition at any Sanctioned, approved or Observed meet (USA Swimming Rule 102.8.1F)

Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet

MAAPP 2.0: All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Athlete Eligibility:

This competition is open to any USA swimming registered athlete. All swimmers and teams must be currently registered members of USA Swimming, Inc. Age is to be determined by the first day of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Image Release:

By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the start of the meet.

Entry Fees:

\$5.00 per individual event, \$28.00 per swimmer pool charge, \$5.00 electronic heat sheet Fee, \$2.00 SCLSC Travel Fund/Program Fee, \$2.00 SCLSC Sports Development Fee, \$2.00 Out- of- SCLSC Travel Fund/Program Fee, \$10.00 per individual Time Trial, \$8.00 per relay Team Entry Fee. Entry fees are non-refundable. Swimmers may swim up to four (4) individual events per day, including Time Trials. Swimmers must provide their own timer for a time trial. The Clerk of Course will close 30 minutes before the start of competition of each session. Late entries fee will be double the original entry fee per event. Proof of registration must be presented.

Meet Format:	The Meet Director reserves the right to adjust the warm-up times & start times. This is a timed finals meet and will be limited to no more than 325 swimmers per session and/or 650 total athletes entered in the entire meet. The Meet Director reserves the right to limit events, heats, number of swimmers per team, or to adjust the format to conform with the 4 hour provision for 12 and Under sessions in accordance with Rule 205.3.1 F. Teams will be notified of any adjustments as soon as the deadline for entries received has passed.
